Overall this was an interesting session. I like the way you structured the session

to get participants to state their goals at the beginning and their outcomes at

the end. However, some participants were quiet and reluctant to speak – so it

might be worth an icebreaker or other activity to make them more willing to talk.

There was also the issue of an abundance of information and at times you

seemed slightly unsure of the session's overall purpose – something to work

on for next time would be to get a clearer focus for the session and find ways

to communicate that to the students.
